### 6.11 ACTIONS OUTSTANDING

a. Bramford Scout HQ – works to building – councillors agreed unanimously to accept the tender from GHB for repairs to the roof. Councillors also requested the clerk research potential grant monies available for additional aspects of the project, including insulation.

The Chairman also advised councillors that a quote for repairs to benches on the village green to be submitted in the near future.

a. Monthly payments – it was agreed to sign cheques to the value of £2,674.74

Councillors requested details relating to payment of invoice for cemetery maintenance for £300 relating to a previous month's payments.

#### **8.11 PLANNING**

- a. 4392/16 Conversion of shop (ground floor) and first floor flat into two dwellings 3-5 The Street
  - Councillors found no grounds for objecting the application however the loss of a village amenity was considered a disappointment.
- b. 4428/16 Erection of a single storey side and rear extension Shangri-La, Whitton Leyer. Councillors found no grounds for objecting to the application.
- c. 4426/16 Real family room extension Kelvinside, Limes Avenue. Councillors found no grounds for objecting to the application.

# 9.11 CLERK'S PENSION SCHEME AND PAY SCALE

- a. Councillors unanimously agreed that their only employee, Diana Stroh, be enrolled on the Local Government Pension Scheme with contributions based on a 50/50 split, back-dated to 1<sup>st</sup> April 2016.
- b. Councillors unanimously agreed to the immediate imposition of the clerk's amended pay scale to be back-dated to 1st April 2016 as per NALC requirements.

# **10.11 TREE SURVEY**

Councillors unanimously agreed to decline to contribute to the costs of tree-felling on land in Flindell
Drive, as requested by MSDC, on the grounds that the Parish Council has no ownership or control
over the land and therefore does not recognise it as a parish responsibility.
