- d. Cemetery Councillors advised that no additional work undertaken to complete this item.
- e. Cemetery Councillors agreed for Clerk to prepare contract in relation to prospective proposals for maintenance of field adjacent to cemetery.
- f. Cemetery Unauthorised structure Councillors advised that local crematorium unable to assist and that response awaited from ICCM.
- g. Cemetery Location of remains Councillors advised that visit to be made to site on Thursday 21<sup>st</sup> Febraury at 9.30am.

- h. Speed Indicator Signs Councillors advised that Westcotex order now confirmed and that payment due following receipt of goods.
- i. Office Replacement computer Councillors advised that Clerk to download cashbook software before new laptop purchased and re-load when full download completed.

- b. Loraine Victory Hall Cllr Earthy confirmed funding for more secure fittings, including £7,000 for replacement security doors, and funding from District Councillor Welsby for replacement flooring.
- c. Bramford Open Spaces Cllr Key advised Councillors of plans to lay flower meadow, in line with project supported by Kew Gardens.
- d. Councillors report i. Cllr Gardiner advised Council regarding ongoing enquiries into street lighting issue, Paper Mill Lane.

## 12.2 CLERK'S REPORT

The Clerk advised Councillors that enquiries were ongoing regarding a water bill for Stationfield Allotments over potential GDPR issues, that a planning site visit was yet to go ahead, that concerns had been raised with MSDC over false newspaper reports regarding CIL funding for Bramford and that Clerk will print off election packs for Councillors. Councillors agreed for Clerk to make enquiries for the purchase of a replacement screen for noticeboard in The Street.

Councillors requested the Clerk enquire with Environment Agency about grass-cutting responsibilities along bank and removal of 'knot-weed' in river.
