Albert proposed (Andy seconded) all in favour to formally object (Clerk to draft formal objection based on the below raised items – needs to completed Wednesday 15th allowing submission prior to deadline)

- 1. Sensitivity to grade 2 listed building
- 2. Amenity value to houses proposed
- 3. Impact to safety to people accessing houses to pedestrian access / Right of way access through pub car park
- 4. Concerned about the viability of the pubs business given the restriction to garden area
- 5. Loss of an asset: The pub is a vital village amenity/facility given the prior closure of the other public house (public demand for using outside space especially covid)
- 6. Events held within he pub will hamper access to housing
- 7. Visibility splays upon access is not in accordance to street guidance
- 8. Car pack reduced capacity (23 to 18) 21% reduction will over spill to road which is already limited in space given terraced housing park on the road could cause additional danger given the corner
- 9. Houses will be clearly visible from the street dwellings are 2 story opposed to the single story of pub
- 10. Will dominate the pub garden (charity events were hosted in the garden these events could possible disappear impacting community social events)
- 11. Heritage report states presence of buildings in this area of pub This is incorrect and no evidence provided
- 12. Possible conflicts between the residence and the pub cant put restrictions on the pub
- 13. Punch (big chain) will benefit from the sale and not the landlord danger that pub will subsequently changed fully into residential
- 14. Trees due to be removed were providing screening to surrounding residence
- 15. Pub will require additional capacity given the already approved increase in dwelling in the village

- 16. Impact to street scene it is relevant. Building opposite are historical
- 17. Not fully compliant with local plan policies / NPPF which protect community facilities
